

Drawing for Computer Laptop Official Rules

1. Eligibility

Laptop Computer Drawing (“drawing”) is open only to residents of the fifty (50) United States and the District of Columbia who are at least twenty-one (21) years old at the time of entry and have complied with the terms of entry pursuant to these Official Rules.

Employees, Board members, and volunteers of Pollinator Stewardship Council (“PSC” or “Sponsor”) associated with the drawing, their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, partners, parents, siblings, and children) and household members of each such employee are not eligible. The Drawing is subject to federal, state, and local laws and regulations. Void where prohibited by law.

3. Agreement to Official Rules

5. How to Enter
